On 28 June 2013, the Company granted share options in respect of a total of 14,600,000 ordinary shares to the Group Managing Director and eligible executives including directors of certain the Company's subsidiaries. Among the aforesaid share options, share options for 2,570,000 shares conditionally granted to the Group Managing Director were approved by the shareholders of the Company at the annual general meeting held on 20 November 2013.
